- (i) The posting of Diploma Engineering Trainee shall be at any Unit of Udupi Cochin Shipyard Limited.

D. Compensation and Benefits, Place of posting

(i) The candidate selected as Diploma Engineering Trainee will have to undergo Two years training during which 1st year the trainee will be paid a consolidated monthly stipend of ₹20,000, 2nd year as advance trainee will be paid a consolidated monthly stipend of ₹23,000.

(ii) On successful completion of two years training, the Diploma Engineering Trainee shall be considered for appointment as Supervisor in TS-1 Grade in the scale of pay of ₹28,000-3%-₹1,10,000 and pay fixed at the start of the scale. In addition to Basic Pay, the incumbent shall be eligible for Industrial Dearness Allowance as applicable, HRA @ 9% of Basic pay, Perks upto 35% of Basic Pay, and other benefits viz. New Pension Scheme, Contributory Provident Fund, Accident Insurance coverage, Leave Encashment, Reimbursement of Medical expenses under the Contributory Medical Insurance policy, Performance Payment etc as per the rules of the company. The monthly emoluments as on date is detailed under:

The Annual CTC (at the minimum of the TS1 scale) is ₹8 lakhs approximately.

(iii) The posting shall be at UCSL/any other UCSL units/project sites as desired by UCSL. However, depending upon project requirements, the candidates are liable to be transferred within different units of UCSL. The appointment to the post carries with it the obligation to serve in any department of UCSL or on-board ships or in any of the units/work sites/ projects undertaken in any part of India or abroad as the case may be.

E. Age

(i) **The upper age limit prescribed for all the posts shall be 25 years as on 18 December 2025, i.e. applicants should be born on or after 19 December 2000.**

(ii) The upper age limit is relaxable by 3 years for OBC (Non-Creamy Layer) candidates and 5 years for SC/ST candidates only for consideration to the posts reserved for the respective categories.

F. Method of Selection

Only candidates who are domicile of Karnataka shall be considered for Short-listing of candidates. The method of selection for the posts shall be through Online Written Tests (Objective Type test and Descriptive Type Test) which shall be conducted out of 100 marks and marks awarded accordingly

(i) **Phase-I - Objective Type Online Test (80 marks)**

The Online Test shall be of **90 Minutes duration comprising of 80 Multiple Choice Questions** in the areas of General Awareness (5 Marks), English Language (5 marks), Numerical Ability (5 marks), Reasoning Ability (5 marks) and Subject Based (60 marks). Each question carries one mark and there will be no negative marks.

(ii) **Phase-II - The Descriptive Type test shall be of 45 minutes duration. The details of Objective and Descriptive type test are as under:**

(iii) Marks are assigned to the following parameters for preparing the final rank list for selection:

(a)	Objective Type Online Test	: 80 marks
(b)	Writing Skills (English Language)	:20 marks
	Total	:100 marks

(iv) Online Written Tests (Objective Type test and Descriptive Type Test) shall be held at various **test centres in Karnataka** as decided by UCSL and test centres **shall be allotted based on the number of online applications**. Applicants have the option to choose test centres in Karnataka for Online Written Tests (Objective Type test and Descriptive Type Test), while completing the online application.

(v) The mark list for each post shall be prepared on the basis of marks secured by candidates in the Phase-I&II – (Objective Type test and Descriptive Type Test), online test. The minimum pass mark each for Objective Type test and Descriptive Type Test shall be as below: -

For unreserved /EWS post- 50 % of Total Marks of each test,

For OBC Candidates- 45 % of Total Marks of each test only for vacancies reserved for OBC,

For SC/ST Candidates- 40 % of Total Marks of each test only for vacancies reserved for SC/ST,

The Descriptive test answer sheets of only those candidates who secure the minimum pass mark and above in Objective type test shall be evaluated.

- (vi) Candidates who score minimum prescribed pass marks and above in the Selection tests shall be short listed for verification of certificates. For each post, the selection shall be subject to verification of eligibility requirements (age, educational qualification, reservation, etc.) for which the candidate should produce the original certificates in proof of age, educational qualification, and certificates for reservation categories (OBC/SC/ST/EWS/PwBD) along with self-attested copies at the time of Certificate Verification, failing which they shall not be considered for further selection.
- (vii) Rank lists of candidates who qualified in all the phases shall be prepared based on the total marks secured by the candidates in Phase I & Phase II. In case, the same aggregate marks are secured by more than one candidate, marks scored in the discipline part of the Objective type test shall be the basis of determining the order of the rank list. In case of a tie thereafter, relative merit shall be decided based on seniority in age.
- (viii) Only those candidates who successfully complete the certificate verification shall be provisionally considered for selection against the notified posts in the order of merit / reservation, subject to medical fitness.

G. Conditions

a. Reservation:

- (i) Government of India Directives on reservation shall apply.
- (ii) Applicants belonging to EWS category should produce a valid Income and Asset Certificate issued by any of the following authorities in the prescribed format. This certificate shall only be accepted as proof of applicant's claim as belonging to EWS, failing which their candidature shall not be considered against reservation under EWS category: -
- District Magistrate/Additional District Magistrate/ Collector/ Deputy Commissioner/Additional Deputy Commissioner/ 1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner.
 - Chief Presidency Magistrate/Additional Chief Presidency Magistrate/ Presidency Magistrate.
 - Revenue Officer not below the rank of Tahsildar and • Sub-Divisional Officer or the area where the candidate and/or his family normally resides.
- (iii) Applicants belonging to SC or ST or OBC (Non-Creamy Layer), should produce a valid recent community certificate issued by the Revenue Authority, not below the rank of the Tahsildar, failing which their candidature will not be considered against the reserved posts, and for other concessions/relaxations applicable to the categories.

b. Qualification:

- (i) The minimum qualification stipulated for the posts must be from a Institute/Examination Board recognized by AICTE/ appropriate statutory authority/State/Central Government.
- (ii) The equivalent qualifications for the following Diploma Engineering disciplines prescribed in clause A are as given under. No claim of possession of any other Diploma Engineering qualification as equivalent to the notified disciplines shall be entertained.

- (iii) Applicants who possess such equivalent qualifications may apply for the respective post and shall attend the online test being conducted in the notified discipline, against which they had submitted their application online.
- (iv) The applicants are required to fill in the exact percentage of marks scored by them in the qualifying examination in the online application submitted for the posts. Some Universities/Institutes /Examination Boards do not award Class or Percentage of marks and allot Aggregate Grade Points (e.g. CGPA/OGPA/CPI, etc.). In case University/Institute/ Examination Board defines criteria for conversion of Aggregate Grade Point into Class and/or percentage of marks, the same shall be accepted. The candidate may also produce the percentage conversion certificate issued by the University. However, where the University/ Institute/Examination Board does not define criteria or provide percentage conversion certificate for conversion of Aggregate Grade Point into Class and/or percentage of marks, the Aggregate Grade Points may be multiplied by 10 to get the required percentage of marks.

c. Service Agreement:

- (i) The selected candidates are required to execute a Service Agreement to serve UCSL at least for a period of five years after successful completion of the training and to pay an amount of ₹3 Lakhs (Rupees Three lakhs) to UCSL for violation of the agreement as liquidated damages. During the period of training and during the period of service agreement, application for outside employment shall not be forwarded. No Objection Certificate for outside employment also will not be issued.

d. Documents to be uploaded Online:

- (i) Applicants are required to ensure that all certificates towards proof of age, qualification, caste, disability etc, a recent passport-size colour photograph, and signature are ready for uploading before the commencement of the online application process. **Copies of certificates/mark sheets in proof of all relevant educational qualifications, certificates in proof of age, caste, disability, experience, etc should be uploaded,** as per guidelines provided in the online application portal, **failing which their candidature will not be considered.**
- (ii) Applicants in regular Government service or in Government owned industrial or other similar organizations should submit their applications online directly to UCSL. However, such applicants are required to upload a declaration (as per **Annexure - I**) that they have informed in writing to their employer that they have applied for the posts notified by UCSL. Such candidates if selected, should join for duty on the date specified in the offer of appointment after being relieved by the employer.

e. Application fee:

- (i) Application fee of ₹ 600/- **(Non-refundable, plus bank charges extra) should be remitted using the Online payment options (Debit card/Credit card/Internet Banking/Wallets/UPI etc) which can be accessed through the Online application portal from 19 November 2025 to 18 December 2025. No other mode of payment will be accepted.**
- (ii) **No application fee for candidates belonging to Scheduled Caste (SC)/ Scheduled Tribe (ST).** They are exempted from payment of the application fee.
- (iii) All applicants for whom the fee is applicable, i.e. except those mentioned at (ii) above, should pay the application fees. **It is important to note that their candidature will be considered only on receipt of the application fee.**

f. **How to Apply:**

- i) Applicants should go to the website www.cochinshipyard.in (Career page → UCSL, Malpe)/ www.udupicsl.com (Career page) and proceed to the link for online application. The application consists of two phases – **Registration** and **Submission of application**. Applicants should not submit more than one application. Application once submitted shall be final.
- ii) Applicants meeting the notified requirements may go through the instructions on the online application page, complete the Registration and submit their application online through the online application facility from **19 November 2025** and the facility can be accessed through our website www.cochinshipyard.in (Career page → UCSL, Malpe)/ www.udupicsl.com (Career page). Application submitted direct or by any other mode shall not be accepted.
- iii) Applicants should ensure that all the entries in the online application have been correctly filled in and application submitted successfully. g. General:

- (i) **Candidates are advised to make sure that they are meeting the eligibility requirements as per the vacancy notification for the posts before submitting the applications.**

However, SC/ST/candidates appearing for the certificate verification shall be reimbursed single to & fro third AC rail fare as admissible for the post as per company rules by the shortest route from the mailing address mentioned in their online application form to Udupi Cochin Shipyard Ltd, Malpe on production of proof. Candidates claiming travel reimbursement are required to submit a copy of the front page **of the Savings bank passbook with the account number and IFSC code**, at the time of certificate verification and the eligible amount of reimbursement shall be credited to their bank account through NEFT. Reimbursement of travel fare shall only be made to those candidates who submit the above details. However, at the time of certificate
